Let your voice be heard: Elect your representatives



FENZ Bill: UFBA/FRFANZ speak at Select Committee Hearing

The Fire and Emergency New Zealand Bill is now at the Select Committee stage. On 21 September, the UFBA and FRFANZ addressed the Government Administration Committee on issues in the FENZ Bill identified by our organisations and members.

Our strong representation comprised UFBA Chair Rick Braddock, FRFANZ Chair Kevin Ihaka, UFBA President Russell Anderson, UFBA Directors Glenn Williams, Bill Butzbach and Nigel Lilley, Tawa Volunteer Fire Brigade CFO Mike Farrand, consultant Murray McKee and myself.

Other brigades that had made independent submissions were also at the hearing, as were NZPFU President Peter Nicolle and Secretary Derek Best.

The Chair of the Committee, Hon Ruth Dyson, welcomed our contingent and introduced the committee members who wanted to explore questions arising from their reading of our submission.

Our main concerns

Rick Braddock introduced the background to the UFBA/FRFANZ submission, stressing it was a joint one made on behalf of UFBA member brigades and fire forces and volunteer members of FRFANZ. He pointed out that volunteer firefighters are unique among volunteers—they do not volunteer for a particular time or a specific exercise or task and they volunteer to support their communities 24/7. Volunteers are absolutely critical, therefore, to the ongoing delivery of our fire and emergency services.

So continuity of service delivery is a prime reason why it is of paramount importance the views of volunteers are uppermost when considering the Bill.

Rick asked the question—“Does the Bill as it is drafted have the full support of fire services volunteers?” His answer was a *qualified ‘yes with reservations’*:

- Volunteers support unification of urban and rural services in principle
- Volunteers support the broader mandate and associated limitation of liability.

But volunteers *do not* support the absence of any indication in the Bill of:

- The organisational structure of FENZ
- The service delivery framework or command hierarchy
- How volunteers will be admitted to FENZ, how they will be recognised, who they will report to and how they will relate to the new organisation.

Rick emphasised we are very concerned the Bill is entirely silent on the relationship between FENZ and brigades and fire forces. We did not necessarily expect to see a fully fleshed-out prescription for the relationship. However, we did expect to see the outline of the skeleton upon which the flesh could be added.

We urged the Committee to report back to Parliament that this critical aspect of the new fire and emergency organisation needs to be addressed in the Bill.

Response Assets

Kevin Ihaka spoke on the proposed transfer of response assets to FENZ—a significant issue for volunteer brigades and, particularly, rural fire forces due to substantial inventories of assets acquired through local fundraising and contributions from community organisations and individuals.

Kevin underscored the need for clarifying the applicable section in the Bill and developing a fair and equitable way to ensure response assets stay in the community that funded them.

Overall thoughts

We were privileged to be among the few submitters to have an extended hearing time at the Committee and came away very positive about the opportunity to be heard.

The hearing provided yet another opportunity to demonstrate the joint commitment of the UFBA and FRFANZ to our arrangement under the MoU to

work together. The depth of knowledge from the breadth of the country in our representation—large and small brigades and fire forces, rural and urban—was a true indication of our commitment to our advocacy for sustainable volunteerism.

Next steps

The report from the Select Committee to Parliament is due by 5 January 2017.

FENZ Day One Blueprint

FENZ recently released a working version of the *Day One Blueprint for Fire and Emergency New Zealand (FENZ)*, providing a high-level description of what the new organisation will look like on 1 July 2017.

The Blueprint makes it clear the establishment of FENZ is only the start of the journey—some changes will be implemented on 1 July, other changes will be actively piloted. However, I reiterate this document is very high-level—there is still no detail on the issues we spoke about at the Select Committee hearing including how the ‘direct relationship’ between FENZ and volunteers will work.

The UFBA and FRFANZ will continue to represent the interests of our members on the major issues set out in our submission.

Provincial Associations meeting

Provincial Association leaders joined UFBA Directors and senior staff for a facilitated workshop on 11 September.

The aims were to discuss how the UFBA can assist Provincials to carry out their roles and functions and to develop a model that will enable Provincials and the UFBA to better work together. Warren Maslin from the Canterbury Provincial Association was selected by the Provincial Associations to give a presentation on the workshop outcomes at the UFBA Conference in Christchurch.

FENZ Bill: Extensive UFBA/FRFANZ member consultation

A high level principle of the UFBA Advocacy Charter relates to **member consultation**: when we propose advocating specific policy positions to Government or the NZFSC, we will consult a representative sample of brigades to ensure we accurately portray the position of a majority of brigades.

The Fire and Emergency New Zealand Bill was introduced to Parliament on 30 June to repeal the Fire Service Act 1975 and the Forest and Rural Fires Act 1977 and give effect to a single unified fire services organisation (FENZ).

On 18 August, UFBA and FRFANZ submitted a joint submission on the Bill to the Government Administration Committee. The submission was the culmination of a significant amount of work during the few weeks available, covering in-depth research, seeking feedback from members through an online survey and widespread consultation with volunteer fire brigades and rural fire forces across most regions of the country.

Consultation roadshow

By the end of September, UFBA Director Bill Butzbach, consultant Murray McKee and FRFANZ officials had attended consultation meetings in Northland, Auckland, Waikato, Hawke's Bay, Wairarapa, Wellington, Manawatu-Whanganui, Nelson-Tasman, Canterbury, West Coast, Otago and Southland.

The meetings were well attended with a good mix of urban and rural members. Host brigades were very generous with their time and hospitality and the roadshow team really appreciated

the great facilities and support that contributed to the roadshow's success.

Members travelled considerable distances to attend the meetings. This spoke volumes about the importance they place on their future in the sector.

More visits are planned prior to this year's UFBA Conference to ensure we hear from as many of our members as possible as time and budget allows.

Quality feedback collected

The first visits related entirely to the collection of face-to-face feedback on the FENZ Bill to inform the joint UFBA/FRFANZ submission to the Select Committee. The visits combined with an online membership survey were put together within a compressed timeframe to meet the submission deadline. This did not impact the quality of the advice members provided to us.

It became evident very early on in the roadshow that there is a large demand for information about the FENZ transition. There is also a multitude of misinformation about the transition process. We therefore

decided to extend the roadshow to assist members to better understand and make sense of what is being planned.

High level of agreement

We recorded a substantial amount of information at the meetings—this will reinforce the quality of the UFBA/FRFANZ contributions to the FENZ transition process over the next few years.

There was a high level of agreement across all locations about the issues raised during the forums. This provided great confidence to the roadshow team about the accuracy of what would be passed on during the various consultation processes on the changes ahead.

A Volunteer Fire Brigade Viewpoint

"The recent UFBA roadshow hosted by Richmond Volunteer Fire Brigade was welcomed by a group comprising Area 17 (Nelson/Tasman) urban and rural officers and firefighters. The joint presentation was very informative of the work being done by UFBA and FRFANZ with the FENZ Transition Team.

I would encourage as many as possible to make the effort to attend a roadshow and 'become engaged' with the pending changes. UFBA and FRFANZ are in a position to advocate on our behalf and the variety of suggestions from the existing membership gives hope that such considerations will get to the right table. By participating, you have an opportunity to be part of history in shaping the new look FENZ organisation.

Special thanks to Bill and Murray for taking the time to deliver the roadshow to smaller brigades and rural locations."

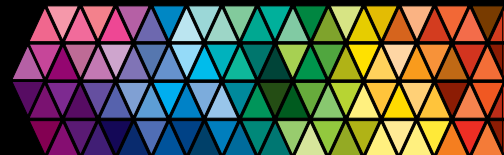
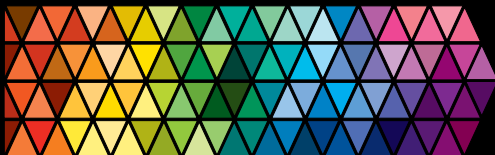
A Rural Viewpoint

Are you a delegate for your brigade at the 2016 UFBA Conference? At the 138th AGM of the United Fire Brigades' Association, brigade delegates have the opportunity to vote for your representatives on the UFBA team.

WHAT WE ARE LOOKING FOR

As a Conference delegate, you have the right to vote on behalf of your brigade as to who you think should be decision makers in the UFBA and how we work for you.

The hard part is deciding who would be the best fit for our organisation and who has time to commit to these volunteer positions, so here are some pointers on what we need to make up the best team for you.

DIRECTORS OF THE BOARD (TWO VACANCIES)

Board Directors play a key role in our organisation. They set the culture and the strategic direction for the UFBA and our team. This will help us grow into a stronger and more effective organisation.

The role of our Board Directors is one of governance, not management, and is clearly focussed on our strategic goals. The wide range of skills and attributes required by the UFBA Board as a whole include:

- Knowledge of the UFBA—who we are and what we do
- Personal attributes such as self confidence, being an inspirational communicator and receptive to new ideas
- General skills including a commitment to best practice governance and experience in strategic planning
- Technical skills in finance, complying with the law, managing risk, Health & Safety, Human Resources.

However, a candidate does not need to tick all the boxes as UFBA will provide newly elected Directors with effective leadership and governance development.

VICE PRESIDENT

The Vice President is a largely ceremonial role but the person who fills this position needs to have many of the same skills and attribute as a Board Director.

There is one candidate for Vice President—**Joe Manihera**. He will speak at the AGM, however, with only one candidate there will be no need for a vote.

TECHNICAL PANEL

Technical Panel representatives ensure UFBA Challenges and their rules are in line with Fire Service policy and techniques.

There is one candidate for the Technical Panel vacancy—**Shayne Kennedy**. He will speak at the AGM, however, with only one candidate there will be no need for a vote.

HOW DO I VOTE AS A DELEGATE?

- 1) We have sent your brigade a specific Voting Card—this will be easy to recognise as it's brightly coloured
- 2) What you need to do before you come to Conference:
 - a) Ensure you complete and sign the Voting Card
 - b) Bring the brightly coloured Voting Card to Conference with you—**this is really important**
- 3) Your Voting Card has two parts:
 - a) The **bottom part**: at registration, you will be asked to hand over the bottom half of your form. Ensure you have completed the left hand side of this section.
 - b) The **top part**: this is what you will physically vote with. You must hold on to the other half and keep it in a safe place for the duration of voting.
- 4) If you forget to bring your Voting Card to Conference, a replacement will be available at the registration desk.

CAN'T COME TO CONFERENCE BUT YOUR BRIGADE WANTS TO VOTE?

PROXY VOTING

If your brigade can't come to Conference this year, you can still vote for your representatives by 'proxy'.

- 1) Each brigade delegate attending Conference can be a proxy voter for another brigade that is not physically attending Conference.
- 2) Ask a neighbouring brigade that is sending a delegate to be your proxy voter.
- 3) Even if your brigade is not attending, you will still receive a Voting Card from the UFBA:
 - a) Complete **the right hand side of the Voting Card**—this card must be signed by your OIC or CFO.
 - b) Arrange to **give your completed Voting Card to the attending brigade delegate** so they can take both their own card and yours to Conference.
 - c) Make sure you give them clear instructions as to how you'd like them to vote.
 - d) They will then be able to cast votes on your behalf.

PROXY VOTES: IMPORTANT NOTES

- Replacement proxy votes are not available at Conference so if you are a proxy voter, it's important you bring the Voting Card.

- One proxy vote for attending delegate is permitted, provided the paperwork is correctly completed by both the non-attending and attending brigades.

THE VOTING PROCESS

- 1) There are two vacancies on the Board. All six nominees will stand for the two positions. As a delegate, you will need a clear direction from your brigade of who to vote for.
- 2) Each of the six candidates will speak at the AGM to give you a summary of their skills and attributes. You can also download their profiles at www.ufba.org.nz/events/2016_ufba_138th_annual_conference
- 3) When it is time to vote, you will be given voting papers for the first vacant position. When you have completed the voting paper, raise your hand holding up the part of your Voting Card that you have retained. Your vote will be collected by scrutineers who will count the votes.
- 4) If in the first vote, one candidate obtains more than half the votes, that candidate will be declared elected. If no candidate secures more than half of the votes, then further ballots will be held until one candidate secures more than half of the votes with the bottom polling candidate being removed from the next ballot each time.
- 5) This whole process will then be repeated for the second vacant position. Be prepared for quite a long process!

MEMBERSHIP SUPPORT

Volunteer Recognition of Prior Learning

From the New Zealand Fire Service

NZFS recognises volunteer personnel may already hold equivalent or higher qualifications and skill levels than those required by Training. Volunteer firefighters/officers who meet the criteria are now able to apply for exemptions from sections of a Training programme or course through the Recognition of Prior Learning (RPL) process.

Some specialist areas such as First Aid and volunteer re-engagement have their own recognition procedures. In all other circumstances the RPL process will apply. Prior learning will be assessed against the requirements of the relevant programme

or course. Evidence of prior learning must be provided to show the volunteer firefighter/officer already has the required skills/qualification.

Work experience will be considered if it is well-evidenced, of significant length and relevance and can be supported with an attestation by a supervisor who can be contacted.

Applications must be submitted at least six weeks before the start date of the programme or course volunteers wish to seek exemption from. The NTC and Programmes Manager and relevant Firefighter/Development Managers will consider each application initially and applications may be accepted, rejected

or provisionally accepted (subject to a successful skill check by a Fire Service Certified Trainer).

Volunteers will be notified in writing of the decision and the reason for the outcome. Training will organise a skill assessment if required.
