Introduction of UFBA Board and Officers

Quorum

The Chair stated that Quorum had been met enabling AGM business to be conducted. 275 Delegates; 18 proxy votes. A majority vote of 50% + 1 is 147

Board Candidates

Incoming Directors Howard Cole and Tom Thomson addressed the delegation.

UFBA Board Strategic Priorities

The Chair provided an update to the delegates on the Board's Strategic Priorities. Following his commitment to members in 2021, he was pleased to advise that the UFBA Professional Standards and the UFBA Complaints and Disciplinary Committee are in place. The Chair was pleased to note that The UFBA has a close working relationship with Fire and Emergency through its Board Chair Rebecca Keoghan and Chief Executive Kerry Gregory.

The Chair called on Fire and Emergency to recognise the depth and intent of the 2017 reforms, reinforced by its own detailed workplan agreed in 2019, and to apply fresh energy to achieving them. Offering, in good faith, UFBA support to help Fire and Emergency's new leadership do so.

The Chair stated that the UFBA will not stand by idly if Fire and Emergency NZ does not stop rogue managers threatening the independence of volunteer brigades, contrary to the legal provisions set out in the FENZ Act. A better course of action is to concentrate instead on updating the Brigade Agreements, Constitutions and

Model Rules to reflect the autonomy of Brigades, consistent with the provisions and spirit of the FENZ Act, as well as ensuring volunteer Brigades are properly resourced through a modernised system of Brigade grants.

In addition to the Independence of Brigades, the Chair called on Fire and Emergency to complete the process of establishing Local Advisory Committees (LACs) across the country, as a priority. Currently, seven have been established of the planned 16.

Following submissions by UFBA regarding Long Duration Incidents, Fire and Emergency has now established the Incident Capability and Payments Alignment project to review and align the way it responds to complex and long-duration incidents.

The UFBA welcomes Fire and Emergency's stated ongoing commitment to volunteerism as set out in its Enabling Sustainable Volunteerism strategy. The recent Proposed People Branch Reset which removes the National Manager, Principal Advisor and Senior advisor (Volunteerism) roles flies directly in the face of that. The UFBA encourage Fire and Emergency to work much more closely and collaboratively with the UFBA to achieve its stated sustainable volunteerism strategy.

This year, Fire and Emergency has not only acknowledged the value of the UFBA's leadership training programme but has also agreed to the UFBA to developing a leadership workshop for its own group and district leaders. We have welcomed this move, and a pilot programme has already been developed and deployed in Ti Hiku Region. We hope it can be expanded in the future.

One area where Fire and Emergency, UFBA and the Professional Firefighters Union have common ground is occupational health and safety and the promotion of overall wellbeing. Every firefighter – volunteer, employed, urban or rural – has the right to protection of their occupational health and safety and support for their emotional wellbeing. That means improvements in health and safety provisions, wider recognition and coverage of workplace induced illnesses, psychological and general health assessments and coverage under the ACC must apply equally to all firefighters. This is something the UFBA has been pushing for and will continue to do so.

Election of Vice President

The two candidates addressed the delegates, then the election took place.

The candidates:

Following the candidate addresses, the Chair reminded delegates that David Turner had voluntarily withdrawn his nomination for the Vice President vacancy. The Chair outlined the changed voting process as follows:

No one can leave the auditorium during the voting process.

At the last Board meeting, the Board agreed with the recommendation from Management that our current auditors, Grant Thornton will be overseeing a modernised voting process.

The auditors collected the votes from delegates.

The number required to elect is 147

Announcement of Successful Candidate Vice President

The Motion was **CARRIED** by acclamation.

The Patron addressed the delegation.

UFBA and Benevolent Fund Subscription Fees

MOTION: That the UFBA membership and UFBA Benevolent Fund subscription fees will remain unchanged.

Moved: CFO Phil New, Te Kuiti Volunteer Fire Brigade **Seconded:** OIC SO Margaret Smith, Porirua Volunteer Fire Brigade

Connection Tour

Chief Executive Bill Butzbach addressed the delegation on the findings of the Connection Tour. He acknowledged all those listening on the live-stream, and especially welcomed CFO Jason Moorefield and SO Tarina Moorefield from the Cook Islands Puaikura Volunteer Fire Brigade.

He advised that during August and September, he and the Chair met many members in local communities – 8 weeks, 18 meetings, with over 250 brigades represented across the Motu. He thanked the Provincials and Sub Associations that invited the UFBA to their forums as part of the tour. It was acknowledged we couldn't get to all parts of New Zealand; however, we covered a lot of ground, and we plan to continue this momentum next year.

Members were advised of 3 key messages UFBA recently put to FENZ as vitally important. Members from the tour valued these insights and acknowledged them as important. That is:

- To maintain the independence of volunteer brigades and the mechanism to strengthen the
 connection between FENZ and volunteer brigades through a modern Agreement of Service that
 clearly outlines expectations, operational requirements, behavioural standards, local community
 risks and needs to constructively have an input to the investment decisions affecting each of your
 communities.
- Brigades need to be resourced for your local risk and need that means fit-for-purpose
 equipment, uniform, adequate training, recruitment, and retention support, to name a few vitally
 important requirements to give you what you need. In addition to the UFBA, your Local Advisory
 Committee is another voice to champion the investment required to allow you to do your job, your
 Brigade needs in your community but less than half the number of the LACs expected, have been
 established in 5 years. The remainder must be setup by FENZ without delay.
- By law, FENZ must apply good employer principles under the Crown Entities Act 2004, to all
 personnel. That includes to volunteers and contractors. This means equitable policies and
 processes, regardless of your employment status, such as the Fleet policy, uniform, rehabilitation,
 and support services, to name a few.

In addition to what we had already put to FENZ, members advised us of over 130 areas that were important to them – some unique to each brigade or area and others were common across the board. Some of the top subjects members raised were:

- Proactive support for mental wellbeing, a fence at the top of the cliff as well as an ambulance at the bottom
- First responder brigades want St John to honour the MOU and make full use of the units

- ACC needs to recognise volunteer firefighting as work-related
- The model rules need to be modernised along with the Agreements of Service
- Members are feeling under-valued
- Review brigade Grants to reflect inflation (note they have done this year)
- Want progression training including leadership and management development
- Improvement to BCO delivery timeframes
- Make more use of and involve the provincials and sub associations

He concluded the presentation by advising that the clear mandate members provided UFBA management for advocacy action has provided a clear focus for a programme of work to be advanced.

UFBA will be preparing a plan for the Board so the Board and members can see progress made on these matters.

Finally in closing, the CE acknowledged that FENZ has commenced work in two areas we have strongly advocated for, payments for long-duration incidents and a unified uniform. We have much ahead of us in the coming years and we look forward to your support and input into the various working parties that we anticipate will come our way.

General Business

There were no General Business items received via email, nor any questions raised from the floor.

Conference adjourned for a short break at 15:00 hours and reconvened at 15:30 hours.

Motions

The Chair welcomed the delegation back from their break and outlined the process for voting on the Motions sent to Brigades one month prior to the AGM.

A resolution was passed by the Board under regulation 6.11 of the constitution to determine the method of voting for the motions to streamline the process and make it simple and efficient. Voting will be by show of coloured card. At registration, delegates received an orange card which denotes a delegate vote and a purple card they were holding a proxy vote for another brigade.

A majority vote will be passed based on a clear visual of the cards held up. Should there not be a clear visual majority, delegates will be asked to stand at your seat. The process was overseen by the scrutineers Grant Thornton.

Motion One

Addition of new clause in UFBA Regulation 3 - Qualifying Service for Awards

Mover: UFBA Board

Seconder: CFO James Hazlett, Ranfurly Volunteer Brigade

MOTION: That 3.4.3 In the case of Operational Support and Non Operational Support personnel, present at Fire Brigade Members' Musters to the satisfaction of a simple majority of enrolled members

In the case of Non-Operational Support and Brigade Support personnel, at Fire Brigade Members' musters to the satisfaction of a simple majority of enrolled members.

The motion was **CARRIED** as amended

Motion Two

Reduce AGM and Special Meeting Quorums

Mover: UFBA Board

MOTION: That the AGM quorum be 20% of Brigade Members (down from 30% currently) and for Special Meetings that the quorum also be 20% (down from 30% currently) of Brigade Members. This would amend the percentage figure to 20% in both Clauses 6.3 and 6.7 of the Constitution.

The motion was overwhelmingly LOST

Motion Three

Two months' notice to notify appointed Delegate

Mover: UFBA Board

Seconder: SFF Glenn Norman, Te Aroha Volunteer Fire Brigade

It is proposed that at least two months prior to a Members' Meeting, each Voting Member must notify the Chief Executive of the name of its appointed Delegate. Amending Clause 6.10(e) to require two months (down from one month) notice.

MOTION: That at least two months prior to a Members' Meeting, each Voting Member must notify the Chief Executive of the name of its appointed Delegate.

Following discussion, the Motion was CARRIED.

Motion Four

Modernise Board Member voting process

Mover: UFBA Board

Seconder: OS Nigel Moore, Gore Volunteer Fire Brigade

MOTION: That the word 'secret' is removed from the voting ballot process.

This would amend Clause 7.4 (b) (ii) as follows:

(ii) There will then be a ballot (via electronic means or otherwise) of all Voting Members entitled to vote either by their Delegate or by proxy;

It is proposed that the candidate with the most votes will be declared elected.

This would amend Clause 7.4 (b) (iii) and (iv) as follows:

- (iii) the candidate with the most votes will be declared elected; and where the votes for candidate are tied, a further ballot will be held;
- (iv) Where the votes for candidates are tied, a further ballot will be held.

Following discussion, the Motion was **CARRIED**.

Motion Five

Process to nominate Vice President

Mover: UFBA Board

Seconder: CFO Phil New, Te Kuiti Volunteer Fire Brigade

MOTION: That nominations for Vice President must be made by a Voting Member on the prescribed form (if any), and include the consent of the nominee, and be received by the Chief Executive at least two months prior to the AGM. Details of all nominees must be sent to all Voting Members not less than one month prior to the AGM.

This would amend Clause 11.1 of the Constitution by including the following clause:

 Nominations for Vice President must be made by a Voting Member on the prescribed form (if any), and include the consent of the nominee, and be received by the Chief Executive at least two months prior to the AGM. Details of all nominees must be sent to all Voting Members not less than one month prior to the AGM.

Following discussion, the Motion was CARRIED.

Motion Six

Changes to the UFBA Benevolent Fund Trust Deed

Mover: UFBA Board

Seconder: CFO Ian Lindsay, Browns Volunteer Fire Brigade

MOTION: That the UFBA Benevolent Fund Trust Deed is amended as per the attached marked-up

document.

Motion Seven

Disputes Scheme Legal Advocacy

MOTION: That it should be policy of the UFBA to fund reasonable legal support for any current or former volunteer who has a dispute accepted to be dealt with under the FENZ statutory Disputes Scheme; and that the UFBA Board shall institute funding arrangements (including from FENZ under s37 of the FENZ Act) and/or appropriate financial savings so as to enable this policy.

Motion Eight

Volunteer Brigade Relationship with Fire and Emergency New Zealand (FENZ)

Mover: UFBA Board

Seconder: OIC SO Margaret Smith, Porirua Volunteer Fire Brigade
